2026 CCA Officer and Director Seats

The following CCA Officer and Board of Directors positions will be up for election at the CCA Spring Conference & Council, **April 24-26, 2026**.

To be a candidate for a District Director, you must have a *faculty* position at one of the colleges within the area represented by that district and be a CCA/CTA/NEA dues paying member in good standing at one of the chapters listed within that district position. The first day to submit a Declaration of Candidacy form is **January 15, 2026**. You may self-nominate until the nominations are closed by the Elections and Credentialing Committee during the Friday session at the 2026 CCA Spring Conference.

The deadline for receiving submitted documents (including election information and campaign posters to be included in the spring conference packet) is **April 10th**. Documents received after that date will not be processed by CCA.
